D. Important Updates

Employees' Pension Scheme (EPS)-95

EOEWA had taken up the matter with CPFC in March 2025. Subsequently, a team met Additional CPFC Mrs Aprajita Jaggi on 21st April 2025. Association continued follow-up with EPFO Dehradun as well as EPFO Head Office not only for members of EOEWA only but for all ONGC members on All India level. We are happy to share that continued efforts have resulted in remarkable progress.

- 1. Out of 6135 approved applications nearly 60% have deposited the required amount
- 2. As on date, more than 70% applicants have received their Revised PPOs with substantial increase. Out of these, more than 40% have received arrears also
- 3. We have a separate WhatsApp group to provide support and guidance for all ONGCians. All are advised to join us. Those interested can contact on EOEWADelhi@gmail.com.
